## Jayhawk Media Workshop

Commuter Release Form 2016

This form explains the policies and procedures for students hoping to attend the Jayhawk Media Workshop as commuter students. These details are necessary to ensure the safety of all students and because the majority of JMW's enrollment is residential students.

We ask you to understand that the policies and procedures below are not able to be changed based on individual circumstances. For instance, commuting students need to comply with the policies below even if they conflict with sports practices, rehearsals, etc. We understand these policies will not accommodate every particular student need. However, our commitment to student safety requires that we insist on the steps outlined below.

Students cannot elect to be commuters for a portion of the camp and residents for another portion. Students must be either commuters or residents.

**Who?** Any student enrolled in JMW may enroll with the commuter plan in any of our available courses.

**What?** A chance to attend JMW for a reduced rate and commute to the workshop each day. Students will attend all instructional times and have the same journalism experience as fellow campers.

**What will commuters miss?** JMW hosts social activities in the evenings. While commuters will attend the Sunday night picnic, they will not attend the Monday, Tuesday or Wednesday evening activities.

**What about meals?** Commuting students will not be enrolled on the meal plan. For that reason, they should bring payment for lunch on Monday, Tuesday and Wednesday.

**How?** Commuting students must check in and out with the counselor tasked with commuter supervision at Corbin Hall. JMW will keep a book used to check in and check out.

**How much?** The cost for commuting students is \$425 for five days instruction, access to JMW computer labs and equipment, Sunday night's picnic dinner, daily camp activities, plus a camp t-shirt and water bottle.

**When?** Please see below for drop-off and pick-up times each day. We request that commuting students arrive on time or early for these times. After pick-up time each evening, we ask that commuting students not return to JMW's activities or Corbin Hall for safety and to ensure that we keep accurate attendance of resident campers.

**Daily Drop-Off Times**

Commuting students must arrive at camp by the following times each day:

- Sunday, June 12: 3:15 pm at Corbin Hall
- Monday, June 13: 7:45 a.m. at Corbin Hall
- Tuesday, June 14: 7:45 a.m. at Corbin Hall
- Wednesday, June 15: 7:45 a.m. at Corbin Hall
- Thursday, June 16: 8 a.m. at Corbin Hall

**Daily Pick-Up Times**

JMW offers commuting students the following departure times from camp each day.

- Sunday: 8:45 p.m. from Corbin Hall lobby
- Monday: 5:45 p.m. from Corbin Hall lobby
- Tuesday: 5:45 p.m. from Corbin Hall lobby
- Wednesday: 5:45 p.m. from Corbin Hall lobby
- Thursday: 11:15 a.m. from Corbin Hall lobby

**Release**
